Learning the ways of ice fishing

After a snowy week, the weekend brought warmer temperatures and sunshine, welcoming Forest County Potawatomi (FCP) tribal members, descendants, and their families together for a day of outdoor winter fun. On Jan. 17, 2026, participants packed up their fish finders, tackle boxes, tip-ups, ice augers, and ice shacks and headed to Devil's Lake for the annual Winter Family Camp and Ice Fishing Contest.

Fishing enthusiasts arrived early to register, with the ice fishing contest beginning at 7 a.m. A warm breakfast followed at 8 a.m., along with hot chocolate and coffee to help take the edge off the crisp winter air. Snow snake tournaments kicked off around 10:30 a.m., adding friendly competition and excitement to the day. Lunch

was served from 11 a.m. to noon.

FCP Emergency Management welcomed attendees alongside LNR, who provided a warming station for all needing a break from the cold. With safety in mind, Emergency Management provided participants with 3-in-1 carbon monoxide detectors with alarms, ice picks, and flotation rescue devices. Participants also had the opportunity to register for a raffle featuring a portable propane heater to help keep winter adventures comfortable.

A bonfire burned throughout the day as visitors came and went - warming up, grabbing meals, sharing conversation, or enjoying sledding down the hill. While many fish were registered, only three winners were awarded in each category.

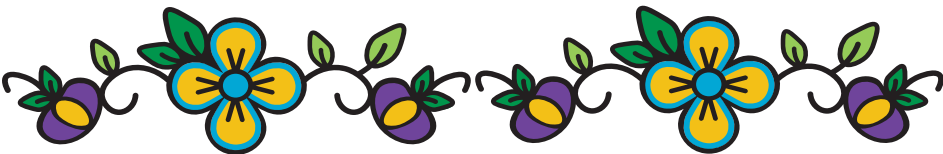



The FCP Executive Council had the opportunity to tour the new Waseya Wellness Lounge at the Potawatomi Community Center (PCC) on Jan. 15, 2026. The name "Waseya" means "bright light" in the Potawatomi language.

The lounge offers state-of-the-art therapeutic services, including an Infrared Sauna, Pulse Electromagnetic Fields (PEMF) Therapy, Red Light Therapy, Halotherapy, Recovery Services (Pressotherapy, Contrast Therapy, Percussion Massager), a Wellness Library, a Relaxation Lounge, and a beverage station.

The Executive Council was very impressed with the new addition to PCC and asked many questions of Wellness Coordinator Ashley Thompson, who will be managing this area and has certification to ensure that the devices used in this lounge are used properly and safely for clients.

Another person who will be helping Thompson when able will be Fitness & Wellness Manager Desiree Marten, who also knows the equipment inside and out to ensure clients' therapeutic needs are met safely and efficiently.

There will be a VIP exclusive access to this lounge Jan. 20-25, 2026, that will be open to FCP tribal members and descendants only, and then an open house for the public will be held on Jan. 29, 2026.

The Waseya Wellness Lounge will be a great addition to the community's well-being and mental health, and will also serve as a bit of pampering in the fast-paced world we all live in. It will help you disconnect from your devices, the outside world, and get your well-being back to relaxation and rejuvenation. He was tasked with establishing a program for the maintenance and operations of all government buildings.

Initially, there was a lot of running around, fixing things, and gathering information. He occasionally received some help from the Construction Management crew, particularly from the HVAC and Plumbing teams. When COVID-19 hit, everyone in his department besides himself was furloughed. After several months, he was allowed to bring back some members of his team. That was when he became the Facilities Manager, a role he never relinquished, even after taking on his current position as Interim Facilities Director.

During Thorpe's retirement, he shared that he and his wife plan to spend about a month in a warmer climate, but then will settle into being an 'old retired couple.' He stated, "I have many honey-do projects that will keep me busy for a long time to come. I have come to truly cherish the people who have worked tirelessly by my side. They will always be considered lifelong friends. I wish all of them the very best, and I promise not to be a stranger in the future."

In honor of his years of service, a retirement celebration was held on Jan. 15, 2026, at the old Tribal Hall. Friends and coworkers gathered for the celebration, enjoying cookies and a delicious retirement cake. Executive Assistant Candace Skenandore shared her appreciation for all of Thorpe's hard work, the relationships he's built, and the friendship they share, in a heartfelt tribute before presenting him with a Pendleton blanket. The team shared many thanks, memories, and laughter as they celebrated his last day.

Greenfire - Village 43 Nearing Completion



As the Village 43 project nears completion, the final phase of construction is underway in Brown Deer at the intersection of Brown Deer Rd. and Green Bay Ave. Developed by F Street Development and designed by RINKA+, the market-rate community introduces 156 garden-style town-home apartments to the rejuvenated

village. Seven residential buildings and the centrally located clubhouse have reached occupancy, with work now focused on delivering the final residential building and completing site-wide finishes.

Greenfire’s involvement with the project began early, with pre-construction planning that established a

clear phasing and turnover strategy. Sequencing was developed to support leasing activity while maintaining separation between occupied buildings and active construction areas. Early site logistics planning also addressed work within a high-traffic corridor, allowing infrastructure, access drives, and parking to be delivered in step with resident use.

Greenfire’s scope included construction management of all residential buildings, the clubhouse, and shared site elements, including utilities, access drives, parking, and open spaces. The team coordinated closely with design and trade partners, managed phased turnovers, and maintained alignment through regular Owner, Architect, and Contractor (OAC) meetings and ongoing safety planning.

Construction activity is now centered on final interior and exterior work for the last residential building,

along with completion of amenities and landscaping, including the dog run for residents with furry friends. Final preparations are focused on maintaining schedule certainty and supporting leasing move-in dates while ensuring continuity across the completed portions of the community.

As Village 43 approaches full delivery, attention is turning to the next phase of work with F Street. Building on the collaboration established in Brown Deer, Greenfire has begun construction management services for The Axis Apartments in West Allis. The project continues the working relationship between Greenfire, F Street, and RINKA+, carrying forward shared standards for coordination, phasing, and execution. Advancing directly from one development to the next shows that a consistent team structure reinforces Greenfire’s focus on repeat clients and long-term project partnerships.

Greenfire - Cornerstone Reaches Milestone



Cornerstone Village – Highland has reached an important milestone with the issuance of its Certificate of Occupancy, signaling that the project is entering its final phase ahead of resident move-in. Located at 3200 W. Highland Blvd. in Milwaukee’s Concordia neighborhood, the development replaces a long-vacant healthcare facility with a new four-story, 84,400 SF affordable housing community. Developed by Cardinal Capital Management and designed by Quorum Architects, the project will provide 71

apartments for elderly residents and adults with disabilities, adding long-term housing resources to the Near West Side.

Greenfire’s value to the project began in pre-construction, where early planning addressed the constraints of a tight urban site. The team coordinated logistics to maintain a net zero fill balance and sequenced work around active street utility improvements along Highland Blvd. Close collaboration with the design team and trade partners supported steady

progress while maintaining alignment on schedule, safety, and quality.

Greenfire’s scope includes full construction management services from pre-construction through closeout. This work encompasses, construction of the underground parking structure, erection of the four-story residential building, enclosure, interior build-out, and site improvements. The team also managed sequencing across the building’s north and west wings to support efficient turnover planning.

As Cornerstone Village – Highland moves toward occupancy, the project adds to Greenfire’s growing body of senior and supportive housing work. This milestone follows the July 2025 delivery of Woodale Crossing for Jewish Family Services. Together, these projects reflect Greenfire’s continued role in delivering housing that supports aging populations and long-term community needs across southeast Wisconsin.

Greenfire - Project Spotlight: Solhaven Grand Chute



Construction is underway at Wangard Partners’ Solhaven Grand Chute. Careful planning and cold-weather execution strategies have kept work moving, allowing the project to advance steadily through the early phases of construction. Located in Grand Chute, Wis., the development expands housing options in a growing Fox Valley market. The development is located in a bustling corridor near Wisconsin Ave. and N. McCarthy Rd., just west of Interstate 41.

Solhaven Grand Chute is a new multi-family apartment community consisting of 82-story residential buildings with 208 units totaling 119,335 SF. The buildings are organized as stacked flats with a mix of studio, one-, two-, and three-bedroom homes. The site also includes a 3,000 SF clubhouse with a pool, attached and detached garages, surface parking, an enclosed dog park, access drives, landscaping, and supporting infrastructure.

Greenfire began adding value during pre-construction by helping clarify priorities, cost drivers, and site logistics tied to garages, utilities, and shared amenities. Early coordination with local stakeholders supported approvals and alignment, while a phased eight-building delivery strategy was developed to support leasing and long-term operations. That planning

continues to guide sequencing and site management.

Greenfire provides CMAR services, leading both pre-construction and construction. The team is responsible for sitework, utilities, building infrastructure coordination, and oversight of trade partners across the full development campus. The project team consists of design from JLA Architects, civil engineering from Pinnacle Engineering Group and structural engineering from Spire Engineering.

Current construction activities include underground utilities, foundation and structural work, and initial framing of the first residential building sequence. During subzero temperatures, the team has maintained concrete pouring operations using tarping systems and forced-air heating. This helps maintain quality and safety standards and the project on schedule.

As work progresses, construction will continue building by building to support phased delivery. Solhaven Grand Chute is another collaboration with Wangard Partners, adding to a history of several completed projects together. That repeat engagement reflects a working relationship built on familiarity with expectations, coordination, and delivery — with Wangard’s resident experience a top priority.

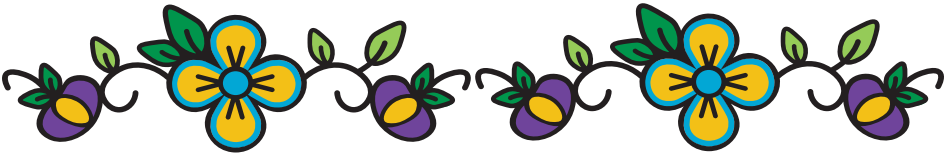
